Investment Rationale: Our HOLD rating is based on: (1) Technical backtest showing 50.0% win rate with +106.2% total return over backtest period, (2) +56.8% upside to analyst consensus target of \$471.55, (3) Strong fundamental growth profile with +16.4% revenue growth, and (4) 79.5% institutional ownership indicating high conviction from professional investors.

Action: Maintain position with -5.9% unrealized gain. Watch for confluence signal to add.

Technical Signal: Confluence 0/7 (threshold: 5) | **Risk/Reward:** Neutral

■ KEY INSIGHT

The fixed stop strategy has proven effective (Win Rate: 50.0%, Avg Return: +32.7%), but patience is critical. Only enter on confirmed signals with proper risk management. Current technical confluence of 0 does not meet entry threshold of 5 - remain on sidelines. Fundamental backdrop shows 188% earnings growth with 80% institutional ownership, indicating strong conviction from professional investors.
