■ KEY INSIGHT

The fixed stop strategy has proven effective (Win Rate: 66.7%, Avg Return: +9.5%), but patience is critical. Only enter on confirmed signals with proper risk management. Current technical confluence of 0 does not meet entry threshold of 5 - remain on sidelines. Fundamental backdrop shows 173% earnings growth with 85% institutional ownership, indicating strong conviction from professional investors.
